- **Free** annual followup SB 198 Plan monitoring by the CMDA's contracted workplace safety & workers' compensation claims consultant.

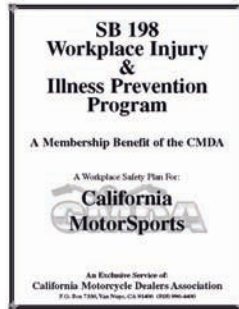
